The U.S. Food and Drug Administration (FDA) continued to take action in the ongoing response to the COVID-19 pandemic:

Today, the FDA is announcing revisions to the patient and provider fact sheets for the
 <u>Moderna</u> and <u>Pfizer-BioNTech</u> COVID-19
 vaccines regarding the suggested increased risks of myocarditis (inflammation of the heart muscle) and pericarditis (inflammation of the tissue surrounding the heart) following vaccination. For each vaccine, the Fact Sheet for Healthcare Providers Administering
 Vaccine (Vaccination Providers) has been revised to include a warning about myocarditis and pericarditis and the Fact Sheet for Recipients and Caregivers has been revised to include information about myocarditis and pericarditis. This update

Serious Adverse Events

Pfizer-BioNTech - Drug Insert

In Study 2, among participants 16 through 55 years of age who had received at least 1 dose of vaccine or placebo (COMIRNATY =12,995; placebo = 13,026), serious adverse events from Dose 1 up to the participant unblinding date in ongoing follow-up were reported by 103 (0.8%) COMIRNATY recipients and 117 (0.9%) placebo recipients. In a similar analysis, in participants 56 years of age and older (COMIRNATY = 8,931; placebo = 8,895), serious adverse events were reported by 165 (1.8%) COMIRNATY recipients and 151 (1.7%) placebo recipients who received at least 1 dose of COMIRNATY or placebo, respectively. In these analyses, 58.2% of study participants had at least 4 months of follow-up after Dose 2. Among participants with confirmed stable HIV infection serious adverse events from Dose 1 up to the participant unblinding date in ongoing follow-up were reported by 2 (2%) COMIRNATY recipients and 2 (2%) placebo recipients.

In the analysis of blinded, placebo-controlled follow-up, there were no notable patterns between treatment groups for specific categories of serious adverse events (including neurologic, neuro-inflammatory, and thrombotic events) that would suggest a causal relationship to COMIRNATY. In the analysis of unblinded follow-up, there were no notable patterns of specific categories of serious adverse events that would suggest a causal relationship to COMIRNATY.

6.2 Postmarketing Experience

The following adverse reactions have been identified during postmarketing use of COMIRNATY, including under Emergency Use Authorization. Because these reactions are reported voluntarily from a population of uncertain size, it is not always possible to reliably estimate their frequency or establish a causal relationship to vaccine exposure.

Cardiac Disorders: myocarditis, pericarditis Gastrointestinal Disorders: diarrhea, vomiting

Immune System Disorders: severe allergic reactions, including anaphylaxis, and other hypersensitivity reactions

(e.g., rash, pruritus, urticaria, angioedema)

Musculoskeletal and Connective Tissue Disorders: pain in extremity (arm)

Unsolicited Adverse Events

Overall, 11,253 (51.1%) participants in the COMIRNATY group and 11,316 (51.4%) participants in the placebo group had follow-up time between \geq 4 months to <6 months after Dose 2 in the blinded placebo-controlled follow-up period with an additional 1,778 (8.1%) and 1,304 (5.9%) with \geq 6 months of blinded follow-up time in the COMIRNATY and placebo groups, respectively.

A total of 12,006 (54.5%) participants originally randomized to COMIRNATY had \geq 6 months total (blinded and unblinded) follow-up after Dose 2.

In an analysis of all unsolicited adverse events reported following any dose, through 1 month after Dose 2, in participants 16 years of age and older (N=43,847; 21,926 COMIRNATY group vs. 21,921 placebo group), those assessed as adverse reactions not already captured by solicited local and systemic reactions were nausea (274 vs. 87), malaise (130 vs. 22), lymphadenopathy (83 vs. 7), asthenia (76 vs. 25), decreased appetite (39 vs. 9), hyperhidrosis (31 vs. 9), lethargy (25 vs. 6), and night sweats (17 vs. 3).

In analyses of all unsolicited adverse events in Study 2 from Dose 1 up to the participant unblinding date, 58.2% of study participants had at least 4 months of follow-up after Dose 2. Among participants 16 through 55 years of age who received at least 1 dose of study vaccine, 12,995 of whom received COMIRNATY and 13,026 of whom received placebo, unsolicited adverse events were reported by 4,396 (33.8%) participants in the COMIRNATY group and 2,136 (16.4%) participants in the placebo group. In a similar analysis in participants 56 years of age and older that included 8,931 COMIRNATY recipients and 8,895 placebo recipients, unsolicited adverse events were reported by 2,551 (28.6%) participants in the COMIRNATY group and 1,432 (16.1%) participants in the placebo group. Among participants with confirmed stable HIV infection that included 100 COMIRNATY recipients and 100 placebo recipients, unsolicited adverse events were reported by 29 (29%) participants in the COMIRNATY group and 15 (15%) participants in the placebo group. The higher frequency of reported unsolicited adverse events among COMIRNATY recipients compared to placebo recipients was primarily attributed to events that are consistent with adverse reactions solicited among participants in the reactogenicity subset (Table 3 and Table 4).

Throughout the placebo-controlled safety follow-up period, Bell's palsy (facial paralysis) was reported by 4 participants in the COMIRNATY group and 2 participants in the placebo group. Onset of facial paralysis was Day 37 after Dose 1 (participant did not receive Dose 2) and Days 3, 9, and 48 after Dose 2. In the placebo group the onset of facial paralysis was Day 32 and Day 102. Currently available information is insufficient to determine a causal relationship with the vaccine. In the analysis of blinded, placebo-controlled follow-up, there

were no other notable patterns or numerical imbalances between treatment groups for specific categories of non-serious adverse events (including other neurologic or neuro-inflammatory, and thrombotic events) that would suggest a causal relationship to COMIRNATY. In the analysis of unblinded follow-up, there were no notable patterns of specific categories of non-serious adverse events that would suggest a causal relationship to COMIRNATY.

5 WARNINGS AND PRECAUTIONS Moderna Vaccine - Drug Insert

5.1 Management of Acute Allergic Reactions

Appropriate medical treatment to manage immediate allergic reactions must be immediately available in the event an acute anaphylactic reaction occurs following administration of SPIKEVAX.

5.2 Myocarditis and Pericarditis

Postmarketing data demonstrate increased risks of myocarditis and pericarditis, particularly within 7 days following the second dose. The observed risk is higher among males under 40 years of age than among females and older males. The observed risk is highest in males 18 through 24 years of age. Although some cases required intensive care support, available data from short-term follow-up suggest that most individuals have had resolution of symptoms with conservative management. Information is not yet available about potential long-term sequelae. The CDC has published considerations related to myocarditis and pericarditis after vaccination,

including for vaccination of individuals with a history of myocarditis or pericarditis (https://www.cdc.gov/vaccines/covid-19/clinical-considerations/myocarditis.html).

FDA warnings: In July, the FDA attached a warning to the Johnson & Johnson vaccine after rare cases of the neurological disorder <u>Guillain-Barré syndrome</u> were reported in a small number of vaccination recipients. Most of the cases occurred within 42 days after vaccination.

FDA WARNING: Johnson & Johnson Vaccine In April, the FDA added a warning label after ending a pause on the vaccine it had recommended "out of an abundance of caution" over an uncommon, but potentially serious, blood clotting disorder that occurred in a small number of recipients.

In December, the FDA updated its <u>fact sheet</u> on the shot to include information about the rare but serious blood clotting disorder called thrombosis with thrombocytopenia syndrome (TTS) associated with the vaccine. The agency still says the risks of the virus are greater than the risks of the J&J vaccine.

Management of Acute Allergic Reactions

Appropriate medical treatment to manage immediate allergic reactions must be immediately available in the event an acute anaphylactic reaction occurs following administration of the Janssen COVID-19 Vaccine.

Monitor Janssen COVID-19 Vaccine recipients for the occurrence of immediate adverse reactions according to the Centers for Disease Control and Prevention guidelines (https://www.cdc.gov/vaccines/covid-19/clinical-considerations/managing-anaphylaxis.html).

Thrombosis with Thrombocytopenia Syndrome (TTS)

Reports to the Vaccine Adverse Events Reporting System (VAERS), a passive surveillance system, provide evidence for an increased risk of thrombosis with thrombocytopenia syndrome (TTS) with onset of symptoms approximately one to two weeks after administration of the Janssen COVID-19 Vaccine. An analysis of VAERS reports of TTS following the receipt of the Janssen COVID-19 Vaccine used the following case definition:

- a thrombosis in an unusual location for a thrombus (i.e., cerebral vein, visceral artery or vein, extremity artery, central artery or vein) and new-onset thrombocytopenia (i.e., platelet count <150,000/µL) occurring any time after vaccination;
- new-onset thrombocytopenia (i.e., platelet count <150,000/µL), thrombosis in an
 extremity vein or pulmonary artery in the absence of thrombosis at an unusual location,
 and a positive anti-PF4 antibody ELISA test or functional Heparin-Induced
 Thrombocytopenia (HIT) platelet test occurring any time after vaccination.

Cases of TTS following administration of the Janssen COVID-19 Vaccine have been reported in males and females, in a wide age range of individuals 18 years and older, with the highest reporting rate (approximately 1 case per 100,000 doses administered) in females ages 30-49 years; overall, approximately 15% of TTS cases have been fatal. Currently available evidence supports a causal relationship between TTS and the Janssen COVID-19 Vaccine. The clinical course of these events shares features with autoimmune heparin-induced thrombocytopenia. In individuals with suspected TTS following administration of the Janssen COVID-19 Vaccine, the use of heparin may be harmful and alternative treatments may be needed. Consultation with hematology specialists is strongly recommended. The American Society of Hematology has published considerations relevant to the diagnosis and treatment of following administration of the COVID-19 Janssen (https://www.hematology.org/covid-19/vaccine-induced-immune-thromboticthrombocytopenia). (see Full EUA Prescribing Information).

Immune Thrombocytopenia (ITP)

Reports of adverse events following use of the Janssen COVID-19 Vaccine under emergency use authorization suggest an increased risk of immune thrombocytopenia (ITP) during the 42 days following vaccination. Individuals with a history of ITP should discuss with their healthcare

provider the risk of ITP and the potential need for platelet monitoring following vaccination with the Janssen COVID-19 Vaccine.

Guillain-Barré Syndrome

Reports of adverse events following use of the Janssen COVID-19 Vaccine under emergency use authorization suggest an increased risk of Guillain-Barré syndrome during the 42 days following vaccination.

Altered Immunocompetence

Immunocompromised persons, including individuals receiving immunosuppressant therapy, may have a diminished immune response to the Janssen COVID-19 Vaccine.

Syncope

Syncope (fainting) may occur in association with administration of injectable vaccines. Procedures should be in place to avoid injury from fainting.

Limitations of Vaccine Effectiveness

The Janssen COVID-19 Vaccine may not protect all vaccinated individuals.

ADVERSE REACTIONS

Adverse Reactions in Clinical Trials

Adverse reactions reported in a clinical trial following administration of the Janssen COVID-19 Vaccine include injection site pain, headache, fatigue, myalgia, nausea, fever, injection site erythema and injection site swelling. In clinical studies, severe allergic reactions, including anaphylaxis, have been reported following administration of the Janssen COVID-19 Vaccine (see Full EUA Prescribing Information).

Adverse Reactions Identified during Post Authorization Use

Anaphylaxis and other severe allergic reactions, thrombosis with thrombocytopenia, Guillain-Barré syndrome, and capillary leak syndrome have been reported following administration of the Janssen COVID-19 Vaccine during mass vaccination outside of clinical trials.

Additional adverse reactions, some of which may be serious, may become apparent with more widespread use of the Janssen COVID-19 Vaccine.

USE WITH OTHER VACCINES

There is no information on the co-administration of the Janssen COVID-19 Vaccine with other vaccines.

The top 6 detoxing agents I recommend to detox and protect against shedding. (My reasoning will be explained below):

- 1. Zeoboost (Zeolite Powder)
- 2. Boron/Borax
- 3. Star Anise/Fennel
- 4. Chlorine Dioxide Solution (CDS)/MMS
- 5. NAC/Glutathione
- 6. Violet Ozone Ray High-Frequency Device

Zeoboost (Zeolite Powder) (Also helps cure cancer, autoimmune, autism, psoriasis, & more): To Detox The Heavy Metals

90 Day Zeolite Detox Instructions:

2 teaspoons of Zeoboost (Zeolite Powder) mixed in 16 oz of water 3 times a day or 3 teaspoons of Zeoboost (Zeolite Powder) mixed in 16 oz of water 2 times a day. I recommend starting with the 2 teaspoons and working your way up to the 3 teaspoons while your body adjusts. The powder does not have a taste so you will not need to worry about this. It is best to mix with water, to avoid the powder binding to anything prior to entering your body. You will follow this regiment for 90 days straight. Zeolite Cautions:

 Taking too much zeolite without drinking enough water may cause dehydration and constipation so make sure you are well hydrated before starting a zeolite detox. To help prevent constipation, increase your fiber intake or supplement with magnesium.

- If you have major kidney problems, be cautious about your water intake and take minimum doses of zeolite.
- If you take more than 10g of zeolite powder per day over a very long period of time it may cause some loss of nutrition.
- DO NOT take iodine within 30 minutes of taking Zeolite
- DO NOT take zeolite at the same time as oil-based supplements, i.e. evening primrose oil or fish oil, as zeolite absorbs oil. Make sure to take these supplements at a separate time of day.





 - PINE TEA: Possible Antidote for Spike Protein
 Transmission Ariyana Love (wordpress.com)
- **C60** (1-3 droppersfull per day): One of the issues we are seeing with those who have been injected is disturbances in their energetic field (magnetism) and hot spots of inflammation. C60 is a rich-source of electrons and acts like a fire extinguisher to inflammation and simultaneously (because it bio-distributes throughout the body) drives a normalization of electron flow throughout the body. C60 is recommended to neutralize spike protein, detoxify graphene oxide and SM-102.
- Activated Charcoal (2-4 capsules a day): Activated Charcoal is the pre-eminent detoxifier and when taken on an

empty stomach, works its way down into the intestines and activates a blood purification process known as "interstitial dialysis". Activated charcoal should not be taken over long periods of time. Take for 5 days, at most, at any given time.

- Citrus fruit (especially blood oranges, due to their high hesperidin content — hesperidin is a chalcone like quercetin that deactivates spike protein)
- **Peppermint** (very high in hesperidin)
- Wheatgrass and Wheatgrass Juice (blades are high in shikimate)

Superherbs to help disable the spike protein:

- Schizandra Berry (high in shikimate)
- Triphala formulations: In Sanskrit, the word Triphala means "three fruits": a combination of Indian gooseberry (Emblica officinalis), black myrobalan (Terminalia chebula) and belleric myrobalan (Terminalia belerica). The terminalia fruits are rich in shikimate.
- **St. John's Wort** (shikimate is found throughout the entire plant and in the flowers)

- Feverfew (leaves and flowers are rich in shikimate)
- Comfrey Leaf (rich in shikimate)
- Gingko Biloba Leaf (rich in shikimate)

- Giant Hyssop or Horsemint (Agastache urtifolia) (rich in shikimate)
- Liquid Ambar (Sweet Gum tree): Rich in shikimate.
- Olive Leaf Extract: Prevents damage from the spike protein. Olive Leaf Extract attenuates inflammatory activation and DNA damage in human arterial endothelial cells.

Blocking vs. Neutralizing The Spike Protein

Blocking vs. Neutralizing The Spike Protein:

- Quercetin or Hydroxychloroquine (HCQ): Quercetin works like HCQ. One of its mechanisms of action is that it blocks the 'virus' (with spikes around it) from attaching. These two supplements will help with spike protein damage and apply to most organs of the body but not all.
- Ivermectin(IVM): Ivermectin blocks spike proteins from attaching to the cell membrane. (Alternative is Neem Oil and "Sweet Wormwood" (Artemisia Annua) — Being used in other countries and has been used to treat Malaria in the past.)
- Dandelion Leaf: Dandelion Leaf Extract blocks spike proteins from attaching to cell membrane.
- Chlorine Dioxide (CDS) or Miracle Mineral Supplement (MMS) Chlorine dioxide neutralizes and eliminates the spikes.

Between a blocker (HCQ, Quercetin, Ivermectin, Dandelion, etc), and a neutralizer (CDS/MMS, Ozone, NAC), I prefer a neutralizer because it eliminates the spikes rather than only blocking them. I suggest alternating this with NAC in case there is Graphene Oxide transmission. I worry that the blocked spikes will continue to circulate and reach the brain and cause all sorts of mental illnesses (Dr. Malone, Bahkdi, Tenpenny, Mikovits). Most people prefer Chlorine Dioxide (CDS) to de-magnetize the body and NAC along with star anise and/or fennel or white pine tea. Make sure to stock up as the FDA is trying to ban some herbs and seeds and supplements.

- · Chlorine dioxide (CDS) neutralizes the spikes.
- NAC or Glutathione neutralizes the Graphene Oxide, as well as spikes to some extent.
- For protection, I will alternate use of Chlorine dioxide and NAC.




Vaccine Patient Blood Samples:




